

Punjab in talks with Centre over AB-PMJAY payments

New Delhi, 23 September

The Government of Punjab is in touch with the Ministry of Health and Family Welfare to discuss the delayed payments to private hospitals under the Ayushman Bharat-Pradhan Mantri Jan Arogya Yojana (AB-PMJAY), senior officials in the know said.

This scheme after the Private Hospital and Nursing Home Association (PHANA), Punjab, and state chapter of the Indian Medical Association (IMA) announced suspension of all treatment under the scheme in state's empanelled private hospitals.

They claimed unresolved payments worth ₹600 crore were pending for the last six months.

An email sent to the Punjab health department did not elicit a response.

The memorandum of understanding (MoU) signed between the state health agency (SHA) and hospitals at the time of empanelment states that the payment for each case must be completed within 15 days of a patient's discharge.

For every payment that remains pending after 15 days, the agency has to pay an interest of 1 per cent.

Punjab had integrated its state health insurance scheme with AB-PMJAY in August 2019, christening it as Ayushman Bharat PM-JAY Mukh Mantri Sehat Bima Yojana (AB PM-JAY MMSBY).

The scheme provides eligible beneficiaries with an insurance of ₹5 lakh per family per year for secondary and tertiary care hospitalisation. It enables cashless treatment across government and private empanelled hospitals in India.

The PMJAY covers households based on the deprivation and occupational criteria of the socio-economic Caste Census (SECC) 2011 for rural and urban areas. The state scheme adds coverage of additional categories such as ration card holders,

India reports first case of Mpox strain that triggered WHO alert

India on Monday reported its first case of Mpox Clade 1b strain, that triggered the World Health Organization (WHO) to declare a public health emergency, in a 38-year-old man from Kerala, who had recently returned from the United Arab Emirates (UAE).

"The Clade 1b strain has been found in a 38-year old man from Kerala's Malappuram district who had tested positive last week," official sources said.

The patient is currently stable, and had recently returned from the UAE,

they said. The Kerala patient is the second Mpox case detected in India since the WHO declared it as a public health emergency of immediate concern (PHEIC) last month after a surge in cases in African countries.

The earlier case of Mpox had emerged in New Delhi, with a 26-year-old man from Hisar, Haryana testing positive for the previous West African Clade 2 strain, which was not a part of the WHO warning. "The patient has been discharged on Saturday," the source added.

"What does secularism mean? Secularism is a European concept, secularism is not a Bharatiya concept," he said.

Parties leave no stone unturned for ST votes in Poonch, Rajouri

Full-scale campaigning is on in the seats reserved for the Scheduled Tribes (STs) in Poonch and Rajouri districts. Jammu and Kashmir (J&K) has nine constituencies reserved for the STs. Among those six are in the Jammu region and three in Kashmir. On September 25, in the second phase of J&K's Assembly elections, all the ST segments of Jammu are going to the polls.

In Poonch and Rajouri districts, there are eight Assembly constituencies, among which five are reserved for the STs. On the stump are the Bharatiya Janata Party's (BJP's) brass such as Amit Shah, Rajnath Singh, and Nitin Gadkari. For the Congress it is Rahul Gandhi and Sachin Pilot, and Omar Abdullah and Mehbooba Mufti are representing the National Conference and the Peoples Democratic Party, respectively.

"I've never seen this buzz and festivity during elections ever before," Habbib Bilal, 33-year-old research scholar in Poonch, told Business Standard.

In J&K, there are 90 seats, increased from 83 after delimitation. Six seats have been added to Jammu, which has 43, and Kashmir, with one addition, has 47. While the tribal Gujjars and Bakarwals

had job reservation, the central government has given reservation to Paharis and other three castes, comprising upper-caste Hindus and Muslims, in March this year.

"Under Narendra Modi's government, our Pahari brothers have reservation now. We've delivered on our promise without touching the Gujjar reservation quota," Union Home Minister Amit Shah said at a rally in Poonch on Saturday.

Last week the BJP's top leaders addressed gatherings in reserved constituencies, highlighting reservation for the Paharis. The Assembly elections in 2014 saw the BJP emerging with 25 seats from the Jammu region and the PDP with 28, which included 25 in Kashmir and three in Poonch and Rajouri districts of Jammu.

In the 2024 Lok Sabha polls, the BJP didn't contest in Kashmir and backed the Altaf Bukhari-led Apni Party candidates. But, it couldn't win any, not even in the remapped Anantnag-Rajouri constituency.

"This was because we didn't field party candidates. Now that the BJP's candidates are in the fray, we're hopeful to win big in ST constituencies. We've done justice in reservation," Ravinder Raina, BJP president of Nowshehra in Rajouri district, told Business Standard.

AVG ASSETS PER CANDIDATE ROSE NEARLY 2X IN J&K POLLS


In its analysis of the affidavits of the 873 candidates contesting the 2024 Jammu and Kashmir Assembly polls, the Association of Democratic Reforms (ADR) has noted that the "role of money power in our elections is evident from the fact that all major political parties give tickets to wealthy candidates".

The average of assets per candidate is ₹3.65 crore. In the 2014 Assembly polls, the average asset per candidate (a total of 831 candidates) was ₹1.93 crore.

Among major parties, the average assets per candidate for 62 BJP candidates is ₹9.13 crore, 56 J&K National Conference (JKNC) candidates is ₹8.26 crore, 39 Congress candidates have average assets of ₹8.08 crore, and 80 People's Democratic Party (PDP) candidates have average assets of ₹5.27 crore.

According to ADR's analysis, 152 (17 per cent) of the total candidates in the fray have declared criminal cases against themselves.
