Pursuant to the effective implementation of the Composite Scheme of Arrangement among National Peroxide Limited, Naperol Investments Limited, and NPL Chemicals Limited as sanctioned by the Hon'ble NCLT on May 4, 2023, the original Naperol Investments Limited (CIN: U65990MH1980PLC022589) has been amalgamated into National Peroxide Limited and ceases to exist. Consequently, its name has been removed from the Promoter category as per the FAQ dated 9th July, 2025 issued by NSE. Post-amalgamation, National Peroxide Limited has been renamed as Naperol Investments Limited (CIN: L66309MH1954PLC009254) and now holds 65,85,117 equity shares of the Corporation. 2. Further, in accordance with the Order dated November 25, 2024, issued by the Hon'ble National Company Law Tribunal (NCLT), Macrofil Investments Limited (Macrofil) has been amalgamated with Nowrojee Wadia & Sons Limited (NWS) under the approved Scheme of Amalgamation. Both Macrofil and NWS are part of the Promoters of the Corporation, and the related procedural formalities are currently in progress. The name of Macrofil Investments Limited is removed from Promoter category.
